iii) Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 80% (eighty percent) or more and value of which is not less than the desired value at(i) above,

In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender, In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executed agency, i.c., the tenderer.

- 1. Registration of Contractor: Any contractor willing to take part in the process of e Tendering will have to be enrolled & registered with the Government e — Procurement system through logging on to https://wbtenders.gov.in. The contractor is to click on the link for e — Tendering site as given on the web portal.
- 2. Digital Signature Certificate (DSC):- Each contractor is required to obtain a class II or class III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the National Information's Centre (NIC) on payment of requisite amount details are available at the Web Site stated in Clause -1 of Guideline to Bidder. DSC is given as a USB e - Token.
- Collection of Tender documents: The contractor can search & download e-NIT & Tender documents electronically from computer once he logs on to the website mentioned Clause 1 using the Digital Signature Certificate. This is the only mode of collection of Tender documents.
- 4. Submission of Tenders:
