iii) Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 80% (eighty percent) or more and value of which is not less than the desired value at(i) above;

Instruction / Guidelines for tenders for electronic submission of tenders online have been annexed for assisting the contractors to participate in extendering participate in e- tendering.

- 1. Registration of Contractor: Any contractor willing to take part in the process of e Tendering will have to be enrolled & registered with the Government e – Procurement system through logging on to https://wbtenders.gov.in. The contractor is to click on the link for a . Tanderica – Procurement system through logging on to https://wbtenders.gov.in. click on the link for e - Tendering site as given on the web portal.
- 2. ## 5. Opening & Evaluation of Tender: - Opening of Technical Bid:

- ii) Decrypted (transformed in to readable formats) documents of the non-statutory cover will be downloaded & handed over to the evaluation committee.
- iii) List of technically qualified tenderers would be uploaded in due course.

NB: While evaluation, The Executive Officer, Guskara Municipality may summon of the tenderers & seek clarification/information or additional documents or original hard copy of any of the documents already submitted & if they are not produced within the supulated time frame, their bid will liable for rejection.
