5. Eligibility criteria for the bidders:-

a) i) Intending tenderers should produce credentials of a similar nature of Completed at least one work of the minimum value of 40% (forty percent) of the estimated amount during 5 (five) years prior to the date of issue of the tender notice;

ii) Intending tenderers should produce credentials of 2 (two) similar nature of completed work, each of the minimum 30% (thirty percent) of the estimated amount during 5 (five) years prior to the date of issue of the tender value of notice;

iii) Intending tenderers should produce credentials of one single running work of similar nature which has been to the extent of 80% (eighty percent) or more and value of which is not less than the desired value at(i) above;

iv) Valid Trade Licence, PAN Card, Professional Tax Payment Challan/Receipt (up to date), Valid Electrical Supervisory Licence/Certificate for Electrical Works Only for works below Rs. 5.00 Lacs vide G.O. Memo No. 410-A/PW/O/10C-9/14, dt. 01-12-2014, no credential of work is required.

In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executed agency, i.e., the tenderer.

b) Scanned copy of PAN card, P. Tax, Valid G.S.T clearance certificate, Credentials, Work Order, BOQ and other supporting documents, Registration Certificate and/or trade License of the company must be submitted duly digitally signed at desired location in the website https://wbtenders.gov.in.

INSTRUCTION TO BIDDERS

Instruction / Guidelines for tenders for electronic submission of tenders online have been annexed for assisting the contractors to participate in e- tendering.

- 1. Registration of Contractor: Any contractor willing to take part in the process of e Tendering will have to be enrolled & registered with the Government e - Procurement system through logging on to https://wbtenders.gov.in. The contractor is to click on the link for e - Tendering site as given on the web portal.
- 2. Digital Signature Certificate (DSC) :- Each contractor is required to obtain a class II or class III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the National Information's Centre (NIC) on payment of requisite amount details are available at the Web Site stated in Clause -1 of Guideline to Bidder. DSC is given as a USB e – Token.
- 3. Collection of Tender documents: The contractor can search & download e-NIT & Tender documents electronically from computer once he logs on to the website mentioned Clause 1 using the Digital Signature Certificate. This is the only mode of collection of Tender documents.
- 4. Submission of Tenders:-
- a) General process of submission: Tenders are to be submitted through online to the website stated in Cl. 1 in two folders at a time for each work, one is Technical bid and other is Financial Bid before the prescribed date and time using the Digital Signature Certificates.
 - b) Technical Bid: Technical Bid contains scanned copies of the followings further in two cover (folder).

A-1. Statutory Cover Containing

- N.I.e.T. (Download the N.I.e.T. and upload the same by digitally sign). í.
- Scan Copy of Declaration as per prescribed format.

N.B: Bidder must download Tender Form No-2911(ii), General Terms and Condition, Special Terms & Conditions, Technical Specifications, all other addendum, Corrigendum etc. whatever documents uploaded by the department in the web site under the e-NIT and must go through carefully before quoting his rate.

A-2. Non Statutory/Technical documents Cover containing.

c) Financial Bid:-

- i) The financial bid should contain the following documents in one cover (folder) i.e. Bill of Quantities (BOQ). The contractor is to quote the rate through on line in the space marked for quoting rate in the BOQ.
- ii) Only downloaded copies of the above documents are to be uploaded, virus scanned & digitally signed by the contractor.

5. Opening & Evaluation of Tender: - Opening of Technical Bid: i) Technical bid will be opened by The Chairman, Guskara Municipality in presence of tenderer or their authorized representatives who may like to be present.

Intending tenderer may remain present if they so desire. Statutory Cover (folder) would be opened first & if found in order and correct Non Statutory Cover (folder) will be opened. If there is any deficiency in the Statutory & Non statutory documents the tender will summarily be rejected.

- ii) Decrypted (transformed in to readable formats) documents of the non-statutory cover will be downloaded & handed over to the evaluation committee.
- iii) List of technically qualified tenderers would be uploaded in due course.

NB: While evaluation, The Chairman, Guskara Municipality may summon of the tenderers & seek clarification/information or additional documents or original hard copy of any of the documents already submitted & if they are not produced within the stipulated time frame, their bid will liable for rejection.

i) Financial bid of tenderers declared technically eligible by the Tender Inviting Authority will be opened electronically from the web portal on the prescribed date and time.

6. Penalty for suppression / distortion of facts:

Submission of false document by tenderer is strictly prohibited.
